Hope for Justice's core U.S. programs help victims and survivors of human trafficking through direct intervention, chiefly in the states housing our three regional centers (Tennessee, Iowa, North Carolina) and nearby areas. This work involves outreach to at-risk communities; trafficking investigations, victim identification and recovery to a place of safety; and survivor support and advocacy through our rise program (restore, inspire, strengthen, and empower), based at our North Carolina center. This integrated suite of services offers trauma-informed care and support, community engagement and comprehensive case management. We also offer training to professionals including law enforcement, healthcare and non-governmental services in the community, and to the public, via instructor-led sessions or our
